

## *RTS' directors meet with the Colombian and Mexican insurance market*

During the Directors' stay in Mexico, RTS also had the chance to meet with prominent members of the sector during a casual meeting organized by [Juan Miguel Álvarez](#), RTS Director in the country, in which they held interesting debates on current matters in the sector such as *'Liability in Cyber Risks'* or *'Prevention for the CAT season'*.
